- ❑ **Housing:** evictions, foreclosures, lock-outs, utility shut-offs, contract for deed problems or trouble getting the landlord or housing authority to make repairs.
- ❑ **Family** - cases for victims of domestic violence, such as orders of protection and divorce; custody cases when the parent who has been child's caretaker is in danger of losing custody; and some divorces. In some areas, we offer self-help clinics on divorce.
- ❑ **Consumer** - debt collection, repossession, garnishments, home improvement problems, and consumer fraud.
- ❑ **Public Benefits and Health** - TANF, SSI, General Assistance, Food Stamps, or Medicaid.
- ❑ **Advance Care Directives**

Caregivers Legal Advocacy Project

Free legal help is available if you are:

- ❑ Family Caregiver who takes care of finances and daily living activities for a person who is 55 or older.
- ❑ Grandparent, Legal Guardian or Relative who is 55 or older who lives with and is the primary caregiver of a child who is 18 or younger.
- ❑ Parent or Relative who is 55 or older who lives with and is the primary caregiver of a person 18 to 59 years old with a disability.

The legal services you seek do not have to be related to providing care.

- ❑ Have you made arrangements in the event your health fails and you are incapacitated?
- ❑ What will happen to your house and those you care for when you're gone?
- ❑ Do you need Food Stamps?
- ❑ Are creditors, housing problems, or loans jeopardizing your ability to care for your relative?
- ❑ Are there other civil legal problems affecting your ability to care for your relative?
- ❑ Do you need medical power of attorney to obtain medical care for your relative?
- ❑ Are you seeking custody of your grandchildren?

Financial Assistance for Kinship Care Providers

Several sources of financial assistance for kinship caregivers currently exist, including: foster care payments; adoption subsidies; child support payments; Temporary Assistance for Needy Families (TANF) child-only grants; food stamps; social security benefits; disability benefits; tax credits; and subsidized guardianships.

Many seniors who are being cared for by their children or other relatives may also be eligible for financial assistance including food stamps and subsidized medical care.
